Motion made by Vince Smith and seconded by Joe Jaime to auction off the old football field scoreboard. Motion passed all in favor.

Motion made by Brandon Foster and seconded by Joe Jaime to approve ESC 16 service center contracts for the 2019-2020 school year. Motion passed all in favor.
