
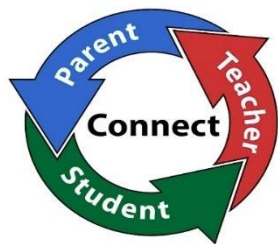


<p>What is Title I</p> <p>Title I is a federal assistance program designed to meet the needs of ALL students at FJHS. All students at FJHS are Title I students and all teachers are Title 1 teachers. Parent/Guardian Responsibilities
