What is Title I

Title I is a federal assistance program designed to meet the needs of ALL students at FES.

All students at FES are Title I students and all teachers are Title 1 teachers. The most recent law that directs Title 1 is the Every Student Succeeds Act (ESSA).

What is the Law?

The purpose of Title I is to enhance opportunities for students to meet and maintain grade level skills (TEKS-Texas Essential Knowledge and Skills). The law requires:

- School districts have a written policy regarding parent involvement.
- Parents be involved in the design, operation and evaluation of Title I.
- Parents be consulted about home/school activities and be informed on how to help their children.
- Whenever possible, activities should be presented in the language spoken by the majority of Title I parents.


