## FARWELL JUNIOR HIGH SCHOOL-Parent and Family Engagement 2024-2025

<b>Statement of Purpose</b>	Farwell ISD is committed to the goal that each student will have the opportunity to enrich to the fullest his/her potential for mental, physical, social, and emotional development so that each student may grow in wisdom, stature, and in favor with God and man. A positive link between the home and school will create the most conducive learning condition for each child. These open communication lines will expand and enhance learning opportunities for everyone involved.
<b>Title I and the Law</b>	<p>The purpose of Title I is to improve the programs of Farwell Elementary, Junior High, and High School and to provide opportunities for children to acquire the knowledge and skills contained in the state content standards (TEKS) and to meet the state performance standards (STAAR).</p> <p>The most recent law that affects Title I is Every Student Succeeds Act (ESSA). The goals of ESSA are as follows:</p> <ul style="list-style-type: none"><li>• All students will reach high standards, at a minimum attaining proficiency or better in reading/language arts and mathematics.</li><li>• All limited English proficient students will become proficient in English and reach high standards, at a minimum attaining proficiency or better in reading/language arts and mathematics.</li><li>• All students will be taught by highly qualified teachers.</li><li>• All students will be educated in learning environments that are safe, drug-free, and conducive to learning.</li><li>• All students will graduate from high school.</li></ul>
<b>Policy Development with Parent Involvement</b>	<p>Districts receiving Title I funds must implement programs, activities, and procedures for the involvement of parents in the Title I program. A written parental policy must be developed and agreed upon jointly by the parents. This committee consists of parents and staff that meet to plan, implement, and review this policy. Meetings are conducted at school at a convenient time for parents.</p>

<p><b>Meetings for Title I Parents</b></p>	<p>FISD will hold an annual meeting to review with parents the Title I program, school parent compact, and Parent and Family Engagement Policy. This meeting is to inform parents of FISD’s participation and explain the rights of parents and families to be involved. The meeting will be offered two different times and will be at a central location. Language translation will be provided to ensure parent participation and attendance. Written notices and media attention will all be directed at attracting as many parents as possible. If a parent is unable to attend a meeting they are encouraged to contact the office. This meeting often accompanies registration and distribution of student schedules.</p>
<p><b>Parent Involvement Opportunities</b></p>	<p>The district will support many varied ways of parental involvement as it strives to develop and maintain an optimum learning environment for all students. At each campus, parents may contribute through volunteer programs at school as well as creating a supportive home atmosphere. <p><b>School Parent Compacts</b></p>	<p>In accordance with Title I regulations, each school must develop a parent-student compact with the parents of students participating in the program.
